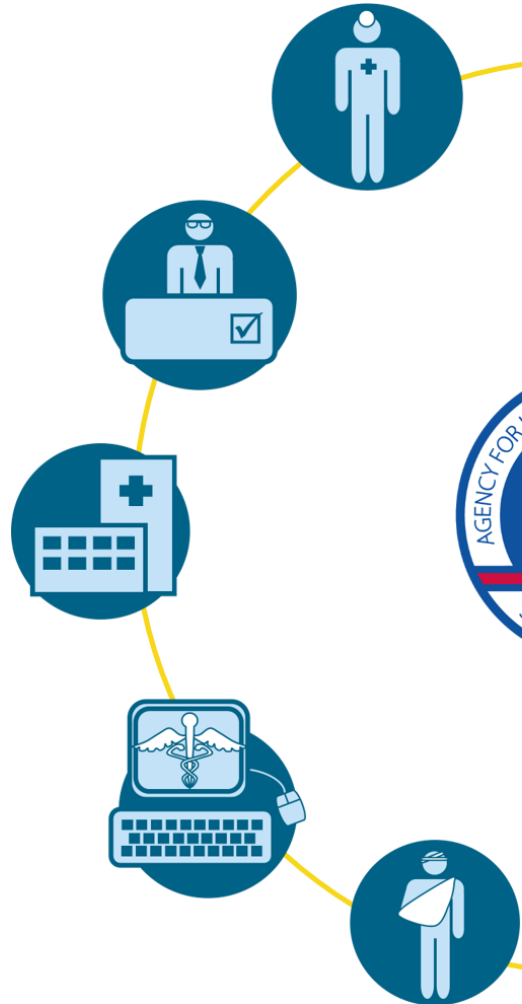

Encounter Notification Service (ENS)

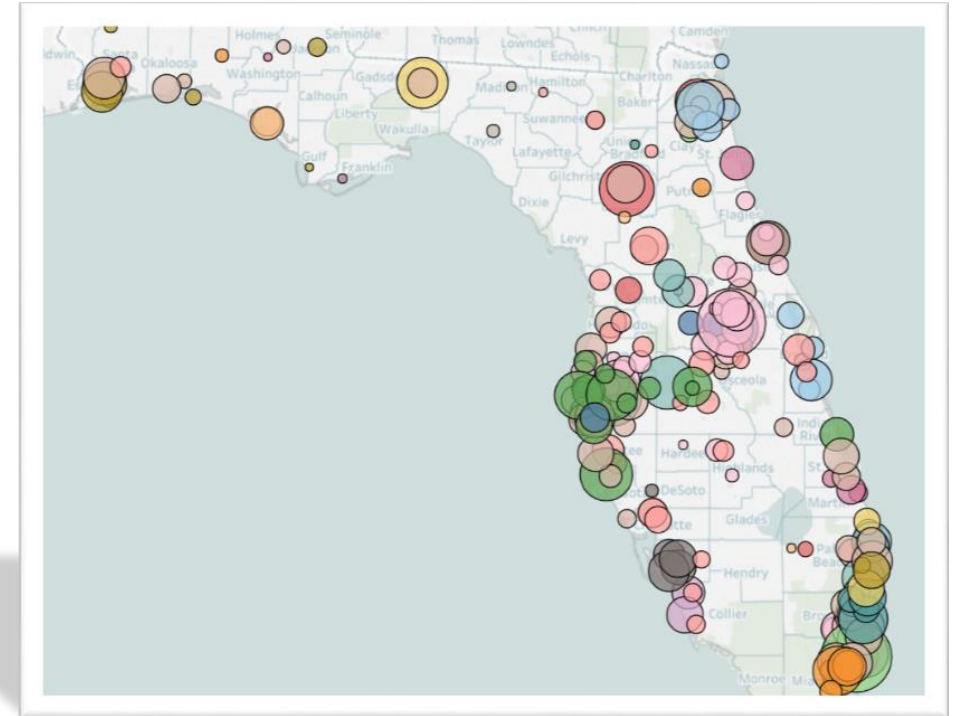


- **ENS provides real-time notice of health care encounters**
 - Hospitals, SNFs, and others send real-time admit and discharge data to ENS
 - ACOs, hospitals, physician practices, and other subscribers provide a list of their patients/members on whom they would like to be notified when an encounter occurs
 - ENS compares these two sources of data, and when a match occurs, an alert is sent out to the appropriate subscriber
 - Subscriber preferences determine how, when, and where alerts are delivered.

Data Sources



- **Data Sources –**
 - Over 300 facilities send data
 - 97% of acute care hospital beds
 - Over 86% of rehab hospital beds
 - Over 140 skilled nursing facilities

Data Subscribers



- **ENS Data Subscribers in Florida**

- 12 health systems in Central and South Florida (80 hospitals)
- 25 Accountable Care Organizations (ACOs)
- 70 provider organizations
- 15 health plans
- Florida Department of Health

- 1M notifications delivered/month

Florida QUERY Exchange



- Built on the nationwide eHealth Exchange
 - Allows providers to query for patient clinical records
 - Federated network with no centralized data repository
 - Common data standards, legal agreement, and governance
- Health Information Exchange MU Requirements
 - Electronically exchanging summary of care records
 - Incorporating electronic summary of care records into an EHR
 - Performing clinical reconciliation using received summary of care records

Emergency Preparation



Deployment of ENS Emergency Census



The Emergency Census leverages the existing Florida HIE's ENS platform to provide a temporary, statewide, searchable census for use during declared emergencies.

Authorized Emergency Personnel can find individuals who have been treated at a facility during the emergency.



ENS Emergency Census Value Proposition for Future Capabilities



- Special Needs shelters will be able to register residents into the ENS.
- Authorized Emergency Personnel could find individuals who have been registered at Special Needs Shelters during a declared emergency
- In addition to routine encounter notifications, Health plans, ACOs, and other ENS subscribers would automatically be notified of a patient's presence at a Special Needs Shelter, which could facilitate more effective care coordination and resource allocation during an emergency
- Evacuations to and from special needs shelters could be tracked
