# SFLHIMSS HIT Education Event for Professionals and Students

## Blockchain in Healthcare 101

On March 13<sup>th</sup>, the SFLHIMSS chapter held its annual student event. This was a well-attended event with over 70 health professionals from numerous areas of healthcare, and graduate students from 11 different universities. Prior to the start of the event, students from the Biomedical Informatics Program at Nova Southeastern University conducted a quick survey asking healthcare professionals, what are the top three skills they are looking for when hiring an entry-level health informatics analyst. Most stated that they wanted the candidate to know a programming language such as SQL, Python or R. Next on their list was having a good attitude, willingness to learn and a self-starter. The third item on potential employers' lists was that they look for communication skills and willingness to take direction.

The speaker for the annual event was Mauricio Angée who is a Certified Information Systems Security Professional (CISSP) with over 30 years of experience in healthcare. Mr. Angée is currently the Chief Information Security Officer (CISO) at Mount Sinai Medical Center in Miami, Florida. He is presently pursuing a Doctorate degree in Business with a concentration in Information Security at St. Thomas University. He is currently an adjunct faculty at Florida International University and St. Thomas University, both located in Miami, Florida. Mr. Angée presented "Blockchain 101 in Healthcare". The agenda covered the basics of blockchain, the digital wallet and the application of blockchain, how blockchain fits into healthcare, and what the challenges are of blockchain in healthcare.

## 2019 Florida Health IT Day in Tallahassee

Our 3<sup>rd</sup> Health IT Day took place on April 24<sup>th</sup> at the Florida State Capitol in Tallahassee, Florida, and was a HUGE success! Thank you to Kendall Brown, Advocacy Committee Chair, and her Advocacy committee members as this event could not have taken place without all their hard work! Additionally, thank you to Krista Riveron, Janine Pratt, and Lou Mendez for making the journey to Tallahassee for this event as well.

Both the Florida House of Representatives and the Senate were in session during Florida Health IT Day from 10am to 6pm. Even still, attendees were able to meet with several staff members and a few elected officials.

The day included 3 presentations, which are available on the SFLHIMSS [website](#):

- Telehealth: William Manzie, Memorial Healthcare System's Administrative Director of Telehealth Strategy

- Interoperability: Summer Kahlon, MD, Steward Health Network's CIO (and CNIL HIMSS incoming President)
- Florida Healthcare Legislative Update: Lisa Rawlins, Maury Brown and Rawlins Managing Partner (and Former SFLHIMSS Advocacy Committee Chair)

Attendees had an in-person meeting with AHCA's new Secretary, Mary Mayhew. Secretary Mayhew wants to collaborate with HIMSS on the future of Health IT in Florida. Also present was HIMSS own Valerie Rogers, Director of State Government Affairs at HIMSS North America, who flew in from Washington, D.C.

SFLHIMSS was recognized in the Senate Chamber by Senator Gayle Harrell, where she presented our Proclamation for Health IT Week. This was a HUGE recognition as April 21<sup>st</sup> to April 27<sup>th</sup> was declared Florida Health IT Week and HIMSS was recognized in a FULL Senate Chamber *during* Legislative Session. SFLHIMSS now has Proclamations from all three Florida Health IT Days, which will be displayed on SFLHIMSS website.

This year, Florida had three telehealth bills and one interoperability bill that directly related to Health IT. This is the FIRST year we have had something relevant to Health IT to speak with elected officials about. As the interest in Health IT continues to increase and becomes a focus of elected officials, next year we can expect a similar trend in Health IT bills.

Legislative session begins in January next year. In order for it to be a success, we must start making relationships at the local district level between now and January, and YOU can help! This includes making relationships with local hospital and health care organization's government relations representatives as well as elected officials. Why Obtain a CAHIMS or CPHIMS Certification?

Certifications are a cornerstone of any rapidly evolving field and obtaining one illustrates your dedication to furthering your professional knowledge and skill set. Certifications demonstrate that you meet a standard of professional body of knowledge. Additionally, many organizations require that candidates have certifications and encourage current employees to obtain certifications.

By getting certified, you can:

- Distinguish yourself in an increasingly competitive marketplace

Currently, HIMSS offers two certifications in the US:

- CAHIMS – Certified Associate in Healthcare Information and Management Systems
- CPHIMS – Certified Professional in Healthcare Information and Management Systems

### ***CAHIMS Certification***

If you are new to the field and/or have limited professional experience, obtaining CAHIMS certification is a great way to expand and diversify your industry knowledge. Recent graduates can use this to polish up their resumes and more experienced professionals can keep up with the ever-changing industry, especially if you've had less direct information technology experience. To be eligible for the CAHIMS exam, the entry-level certification program requires a high school diploma or equivalent and the exam content spans general, foundational knowledge about the industry.

The CAHIMS credential will help you:

- Demonstrate professional knowledge in healthcare information and management systems to potential and current employers
- Establish a solid foundation that will give you an advantage as you strengthen your abilities, acquire more experience, and advance your career path

### ***CPHIMS Certification***

The CPHIMS certification is **designed for professionals with proven industry experience** and is considered the flagship of HIMSS certifications. To be eligible for the CPHIMS exam, you need a bachelor's degree from accredited college or university AND five or more years of information and management systems experience; three of them in a healthcare setting OR a graduate degree or higher from an accredited college/university AND three years of information and management systems experience, with two of those in a healthcare setting.

The CPHIMS credential will help you:

- Demonstrate that you meet an international standard of professional knowledge and competence in healthcare information and management systems
- Increase your credibility with your employer

### ***The Value of HIMSS Certifications***

In a field experiencing such vast change, it's important to possess a standard body of knowledge and an up-to-date skill set that shows you are well informed and well prepared for what is ahead in your career.

- You'll establish a standard body of knowledge which demonstrates your growing expertise of health information and technology subject matter.
- You're setting yourself apart from others in a competitive marketplace.
- You'll expand your opportunity for career advancement.
- It shows you are getting involved and engaging further with your work outside of your regular job.

There is nothing quite as valuable as the knowledge you will cultivate throughout your career and obtaining and keeping active HIMSS certifications is a fantastic way to keep that knowledge up to date.
